- **Invocation and Pledge of Allegiance**


The meeting began with an invocation led by Mr. Fanning, followed by a recital of the Pledge of Allegiance.

Washington, Georgia's Mayor and City Council went into executive session on October 20, 2025, at 8:10 p.m.


